We are part of the world's largest responsible business initiative connecting UK companies and other organisations in a global movement dedicated to driving sustainable growth. We promote practical sustainability leadership, share knowledge across sectors, and actively shape the responsible business environment to create a world we want to live and do business in.

The UN Global Compact's universally recognised Principles, rooted in UN treaties, provide a robust foundation from which we lead UK business action on the Sustainable Development Goals (SDGs). We use our power to convene business and other organisations to find practical solutions to global challenges.

2021 Fee Schedule

The UN Global Compact welcomes participation from both business and non-business stakeholders committed to advancing our Ten Principles and achieving the Sustainable Development Goals.

Companies can choose between two Engagement Tiers, Participant or Signatory, with differentiated fees and benefits (see overleaf for more details). Engagement Tiers do not apply to non-business participants.

UK-headquartered companies on the Signatory Tier with greater than USD 50 million global annual turnover and all UK-headquartered companies on the Participant Tier are required to make a financial contribution to support the work of the Global Compact at both global and local levels (per the dark-shaded Fee Schedule below). This fee includes membership in the UN Global Compact Network UK.

Participating companies not subject to the mandatory fees are not automatically members of the UK Network, but are strongly urged to join. UK Network fees for subsidiaries, non-business participants, and Signatory companies with less than USD 50 million annual turnover are in the light blue section of the Fee Schedule below.

Subsidiaries are obliged to take on the Engagement Tier of their parent company.
