Global Compact Network UK – Register of Members

Global Compact Network UK (GCN UK) is a charitable company limited by guarantee registered in England and Wales (Company number: 08567552 | Charity number: 1202147). This is a widely used legal structure for not-for profit organisations. As a limited company, we have members rather than shareholders. Members of the company, while not owners, have control over the Network. Only company members can:

- Vote at the Network's annual general meeting on any significant changes to the company and its purpose;
- Vote for Trustees;
- Be members of the Network Board and Network Advisory Group.

The rules within which we must operate as a charitable company limited by guarantee (Companies Act 2006 and Charities Act 2006) make a distinction between being a member of the Network and a member of the company. The only cost of being a member of the company is that in the unlikely event that the company is wound up, members may be asked to contribute a token amount of £1 towards any outstanding debts.
